A musical event suggested by Sandy Kauffman is schedule for September 28 at the Stoltzfus House from 10am to 5pm. As Mose Smucker has emphasized, the auction is a time of reunion where our connections are respected. This event will encourage more local attendance while respecting heritage values. Sandy led the effort to prevent demolition of the House in the 1990's, and the preservation was the result of the Pequea Bruderschaft decision beginning in 1997 at the time of a heritage tour.

Sandy is married to John Kauffman whose Stoltzfus score is four. That is how many of his 16 gr-gr-grandparents were Stoltzfus! But Sandy feels for those interested in the Stoltzfus House who are not Stoltzfus.

Sandy's interest in the House predates 1988 when the Schlegel family still lived in it. She, with Pam Shenk, Carole Wilson, and Lois Ann Mast were able to acquire eligibility for the National Register of Historic Places.

A Stoltzfus Story: Dave Coleman

I can remember my grandmother talking about Tennessee John but don't ever remember anything about Nicholas until I read a story in one of the papers a few years ago about the Nicholas Stoltzfus House and then later on facebook. Had planned on coming to the auction last month but it was raining pretty hard so I stayed home.

I just read Eine Wurzel Tennessee John Stoltzfus by Paton Yoder.Can remember when I did mail routes in the Wagontown area just north of Coatesville I delivered mail to a couple of Amish Stoltzfus families.

I have a niece who is a student at Pequea Valley High School and she said Stoltzfus is a very common name there. Told her they are probably all related to her somehow. I would assume the Stoltzfus' in that area, Gap, etc would be Tenn John's children's decendents, those who did not follow him to Tenn. and the Amish in the area would be from his children that did not leave the Amish? Guess that would make some of them my fourth cousins?

I do find this very interesting, I have a lot of nieces and nephews (great nieces and nephews too) I want to put together a little bit of this history for them too. Paton Yoder's book was a very good source of info. I didn't know it but several years ago I was at the Red Bridge near the Nicholas house. It isn't far from here. probably 45 minutes, I do plan on coming up sometime.

Govenor Leader: His Stoltzfus Moment

(Govenor George Leader: 1/17/1918 - 5/9/2013)

The Allgyer reunion was June 29, organized by Michael Allgyer. Gov.Leader had insisted he do all the excavating as they were building. Mike told me the governor asked him to tear down the Stoltzfus House around 1990, but before he got to it the Governor called and asked him to hold off until he has further word. This made me curious, so I asked Michael Leader about this, and here was his response:

Hello, Paul. You have more information about the history of the Stoltzfus Homestead than I do. Someone once told me that some Amish found the location of the homestead when researching the old deed books in Berks County Court House. The first thing that I recall is that the Thunes placed a condition on the purchase agreement for the home that provided the owner must allow the Amish to restore their ancestral homestead. Prior to that time, neither my father nor I had any idea that this was an historic property or that it had once been occupied by Nicholas Stoltzfus. When he learned this, naturally Dad agreed to allow the Stoltzfus family to restore the home. My dad was very proud that Country Meadows was involved in preserving such an important part of the history of the Amish community in central Pennsylvania. Mike Leader
